Registration Policies

Registration is on a first come, first served basis. \$100 non-refundable deposit required, entry in a session is not guaranteed until the deposit is received. Unless otherwise specified, only the deposit will be charged upon registration. By checking the "charge my card" box below, you authorize The Painting Paw to apply the balance due to the card indicated. Unless the "charge my card" box is checked, **a balance will be due two weeks prior to camp start** date. Payments not received by the due date may be subject to a \$10 late processing fee and/or removal of camper from session.

Registrations received with less than 7 days prior to a camp session will incur a \$15 late registration fee.

Camper must be at least 7 years old by the first day of camp. Camps are drop-off only; only registered campers are allowed in the camp area.

Registration forms must be completed in full, signed and faxed, mailed or delivered to the studio with payment via cash, money order or credit card for the deposit amount. Phone registrations cannot be taken. **PERSONAL CHECKS ARE NOT ACCEPTED.**

Refunds and Withdrawals Policy: Deposits are non-refundable. Payment in full for campers withdrawn after camp start date is non-refundable. Due to schedule and nature of projects, campers who miss projects due to being late, leaving early or missing a camp day will not be allowed to make up projects. Credits will not be given for missed projects.

Session Changes & Cancellations: Campers may switch sessions with a minimum of two weeks notice, subject to availability. The Painting Paw reserves the right to cancel, combine or reschedule classes to adjust for enrollment. In the event of a cancellation, students may transfer to another camp or receive a full refund.

Camper Behavior: To ensure a positive experience for all of our campers, The Painting Paw will remove disruptive children from the session. If a camper is asked to leave, payment in full will be forfeited.

Project Pick Up: Projects will first be made available for pickup at the Art Show on the Monday evening following the camp session. In the event you cannot attend your art show, we will schedule you into the next week's show. After 2 show attempts, you may pick up projects at the studio during normal business hours. All camp projects left for over 30 days will become the property of The Painting Paw and will be disposed of. No refunds, credits or make-ups will be given.
